Re: ECMA calls the European Commission for action to combat late payments

Dear Mr. Breton,

The entire European economy is negatively affected by late payments; ECMA represents manufacturers of cartonboard and folding cartons supplying packaging for brand owners and retailers. For many years, our industry has faced demand for increasing payment terms and this has been accelerating during the Covid-19 crisis.

The Late Payments Directive 2011/7/EU was adopted in February 2011, to combat late payments in commercial transactions. The specific objective of the Directive was:

- To provide creditors with timely payments and measures that enable them to fully exercise their rights when paid late.
- To confront debtors with strict measures that discourage them from paying late or from establishing excessively long contractual payment terms.

My organization wrote to your Directorate in June 2018, to inform the then Commissioner, Ms Elżbieta Bieńkowska, that in reality and despite the Late Payments Directive 2011/7/EU, the payment terms within our industry were still increasing. I am writing to you today to inform you that the situation has not improved and that further action is required – this supports the report from the European Commission in August 2016 concerning the implementation of this Directive and which confirmed that "half of all creditors do not exercise their right to claim late payment interest, compensation and recovery costs as provided by the Directive for fear of damaging their commercial relationships." The European Commission's own evaluation study concluded "80% of companies experienced late payments during the past 3 years"

Clearly and according to the European Commission's own evaluation studies, late payments continue to be an issue; they particularly effect SME's who feel unable to challenge the longer payment terms being imposed by larger companies -and I would emphasize that this issue is growing at an alarming rate during the ongoing Covid-19 crisis.

I am requesting your Directorate and the European Commission take renewed action to tackle the increasing incidence of late payments in contravention of The Late Payments Directive 2011/7/EU. It is, of course, so important that legislation introduced by the European Commission is adhered to fully and I look forward to receiving your response.
